### Question 1

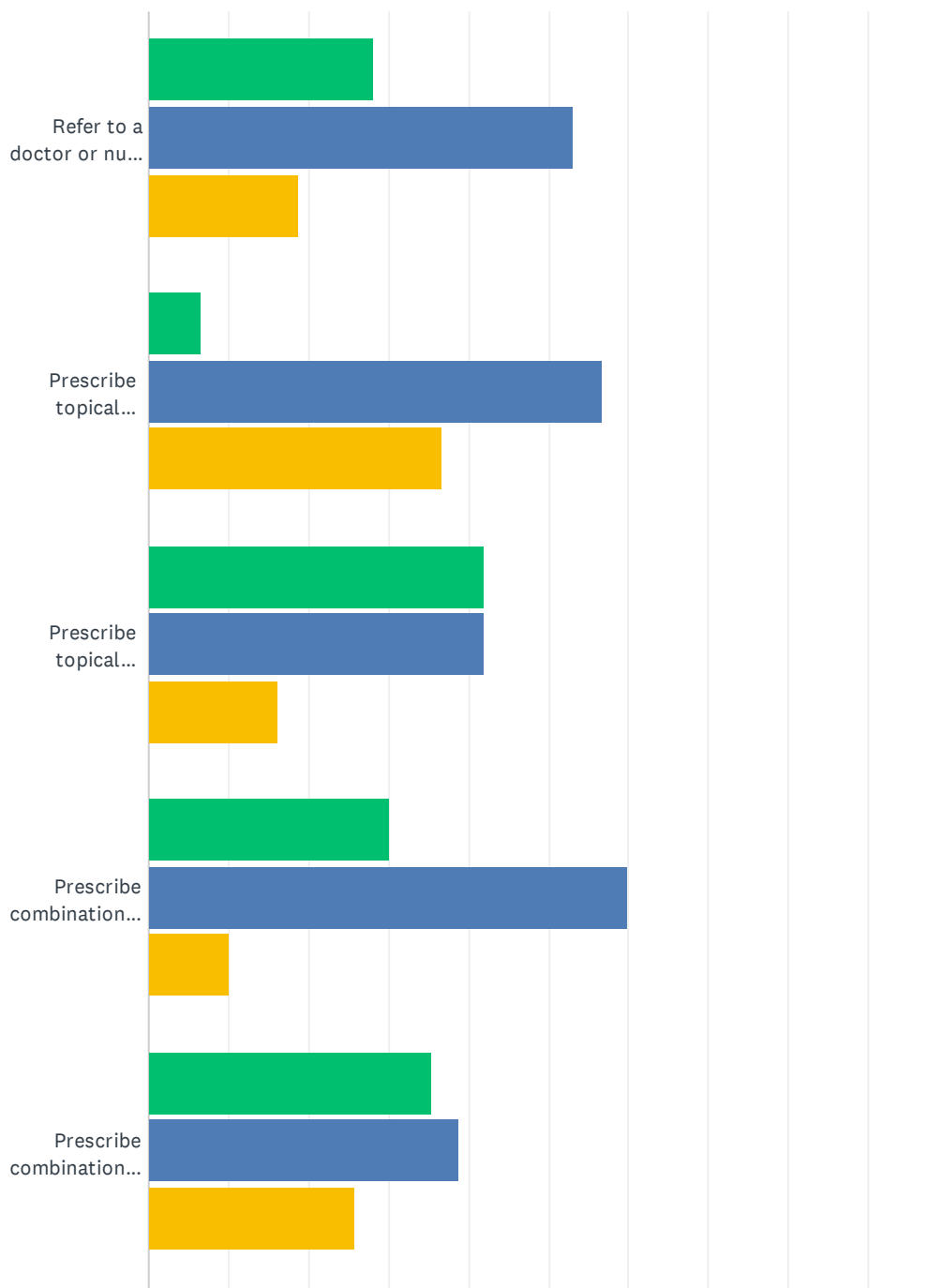
- A lot of reasonable options listed. No one is prescribing oral antibiotics:
  - Refer – 28% Action I would take, 19% Not appropriate
  - Prescribe topical retinoids – 42% - Action I would take, 16% - Not appropriate
  - Prescribe adapalene/BPO – 35% - Action I would take, 26% Not appropriate
  - Prescribe BPO/Antibiotic – 30% - Action I would take, 10% Not Appropriate
  - Prescribe Topical Retinoids/Antibiotics – 23% Action I would take, 33% Not appropriate
  - Prescribe oral antibiotics – 0% Action I would take, 77% Not appropriate.

### Comments

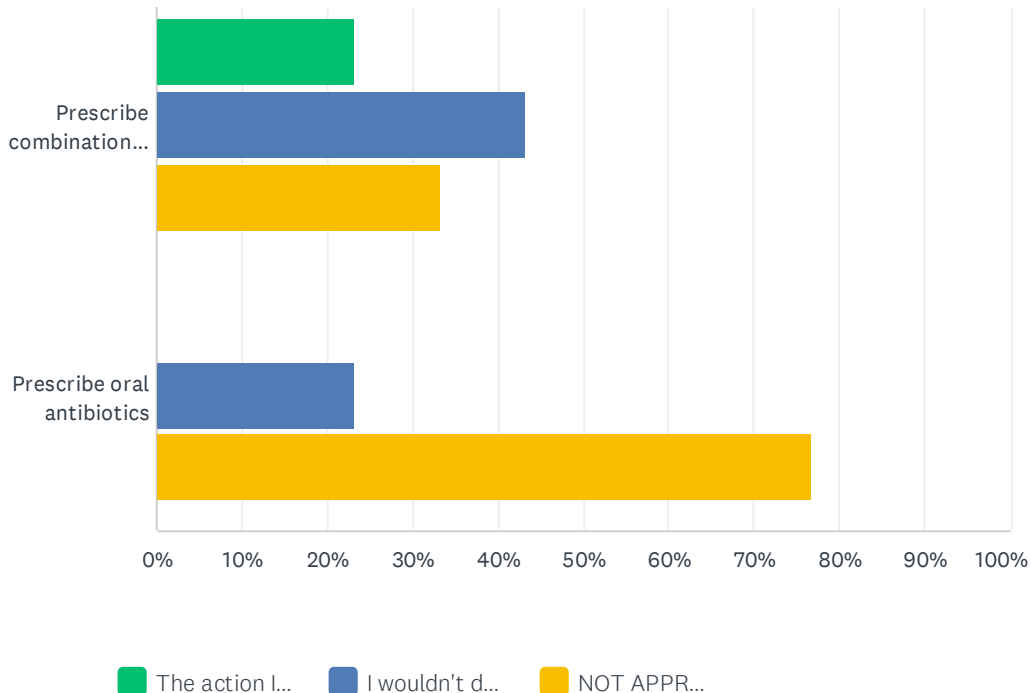
- Depends on how widespread the lesions were.

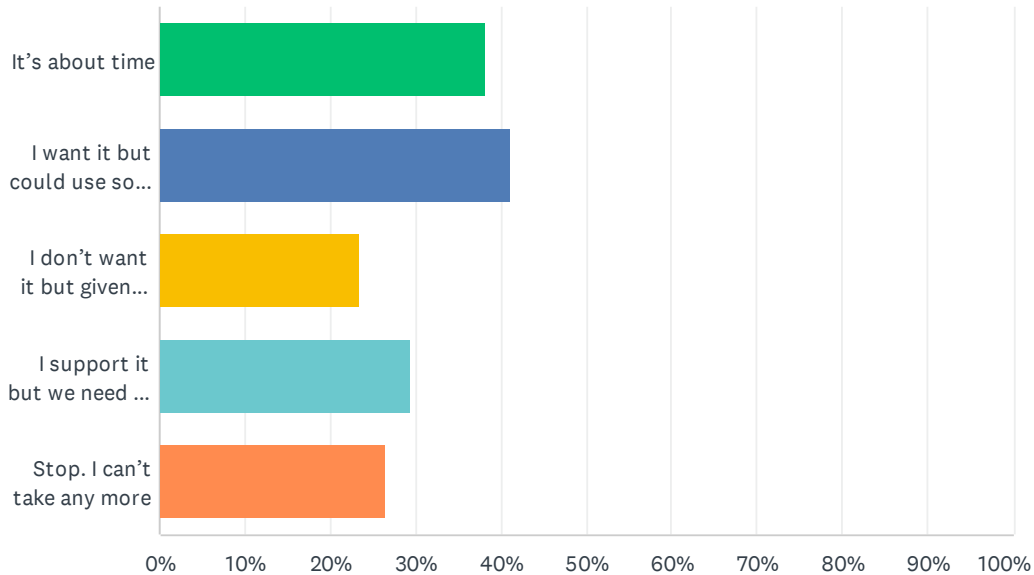
