Question 1

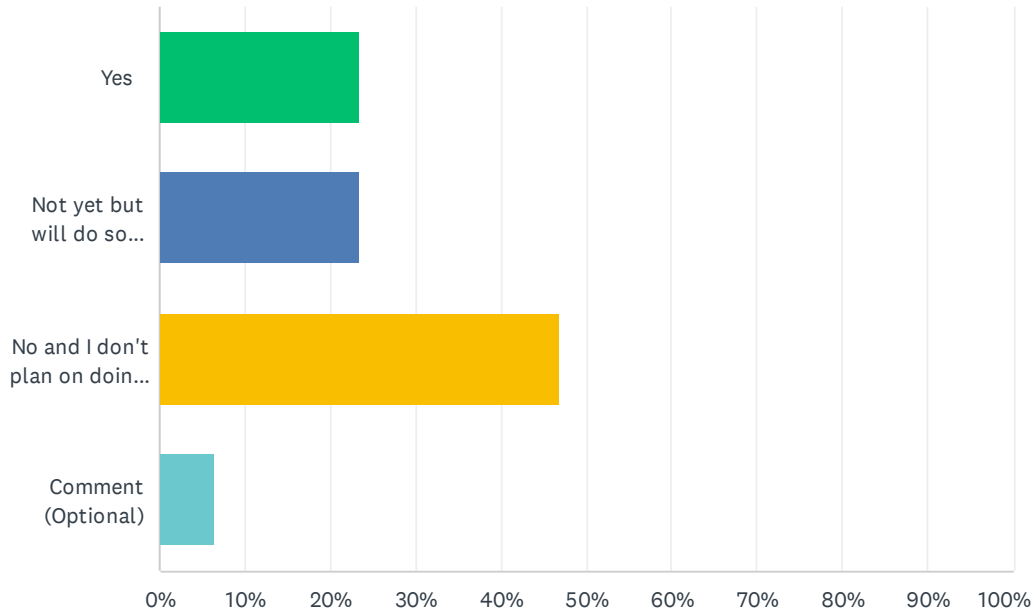
- With regard to training for infant (6 to 24 months) vaccinations:

Question 2

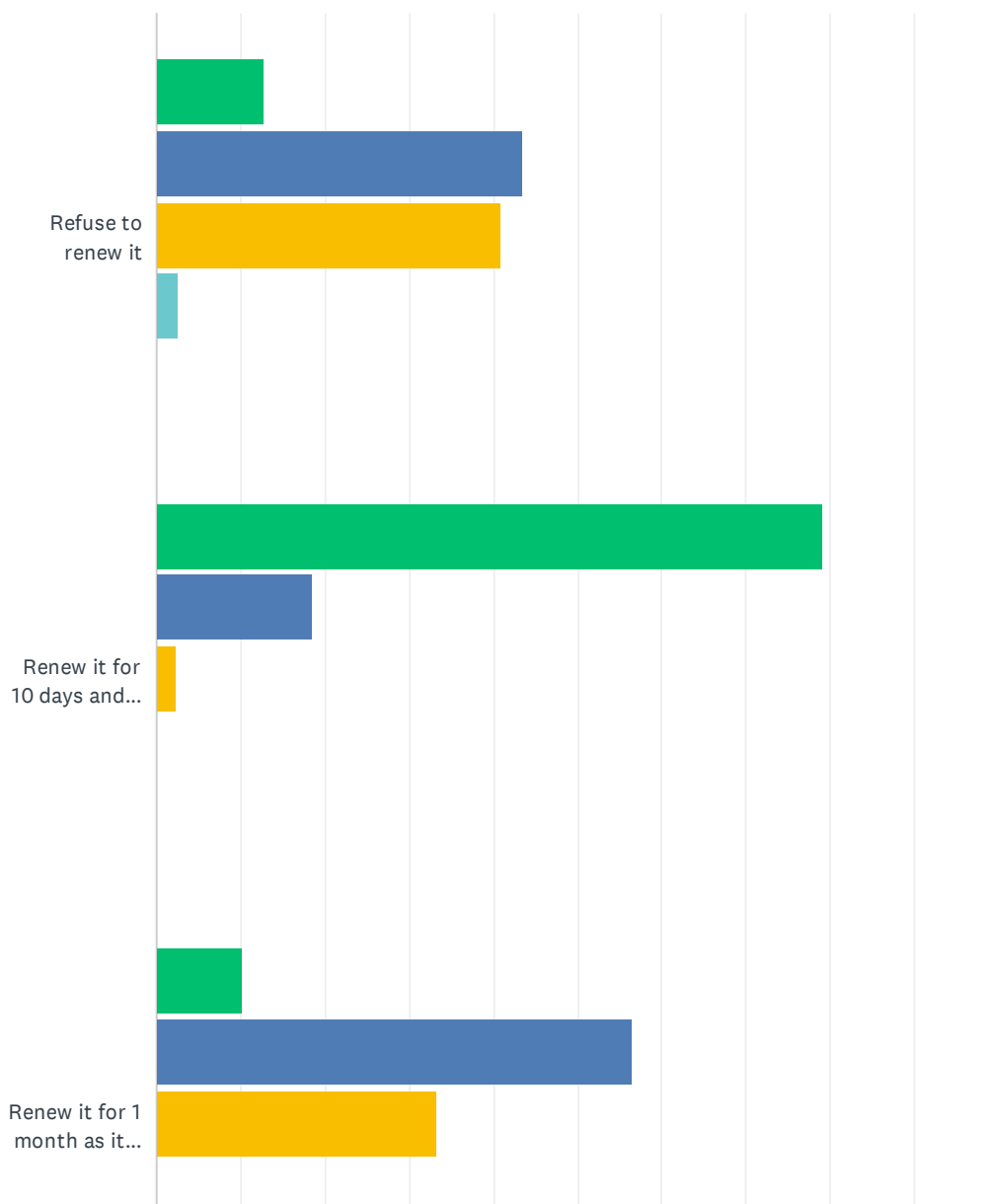
- Predictable split and just as predictable that every option was a preferred option for someone.
 - Give 10 days and make him make an appointment – 79% Action I would take, 2% Not Appropriate
 - Refuse to renew it – 13% Action I would take, 41% Not appropriate
 - Renew it for 1 month and warn that this is the last time – 10% Action I would take, 33% Not appropriate
 - Keep renewing it for 1 month at a time as long as it's indicated – 5% Action I would take, 65% Not appropriate

Comments

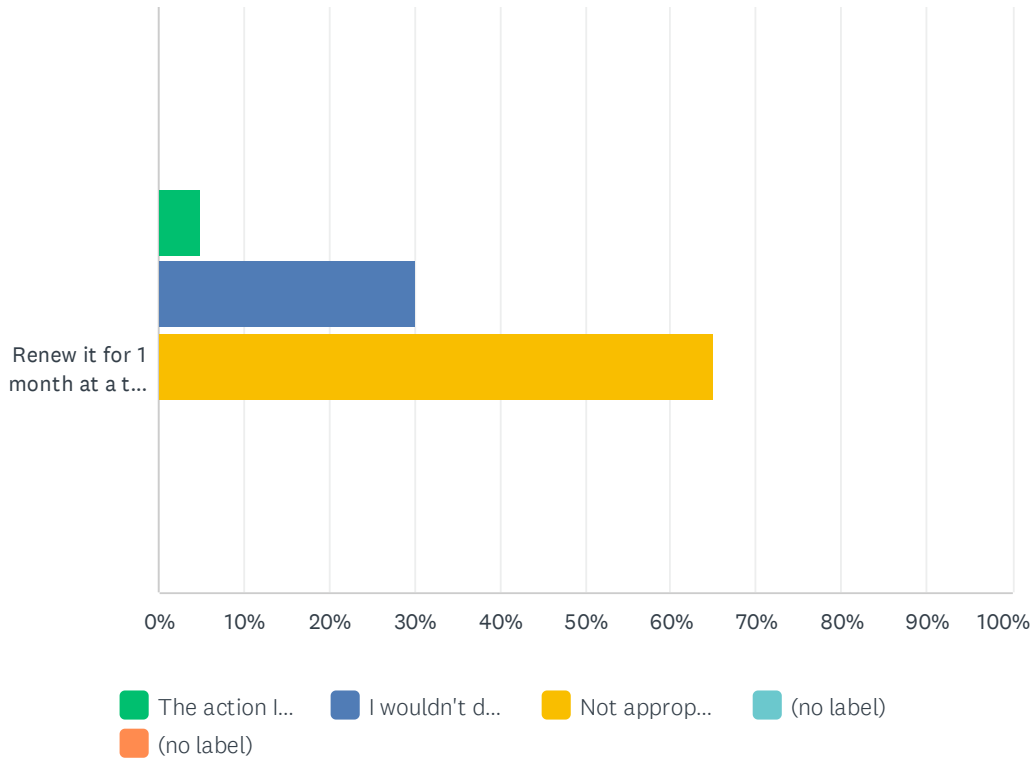
- I would only give him a 4 day supply to get him to his appointment
- I would provide enough to get him to his appointment only.
- It depends on the situation. If he is using it for anxiety and isn't taking an antidepressant, I would give him 7 days to allow his physician to assess need for additional therapy.
- I would not keep continuing it know the physician wanted to see the patient. I would not let him go without but I would want to know that he has an appointment first. This prescribing shouldn't replace usual follow-up care.
- I would give him 10 days because almost any indication would meet the criteria for supplemental therapy or deprescribing. Also, I would remind him after 4 Assessments this will cost him \$12.

Q2 JD calls because his lorazepam 1 mg po bid will run out and he has no refills remaining when he runs out. He wants to know if you will renew it. You did a renewal for a 1-month supply last month and told him he needs to see his doctor. You've spoken to his doctor who wants to see him before giving him more medication. JD can get an appointment with his doctor in 7 days and he has about a 3 days of his medication left. JD tells you he doesn't want to go see the doctor as it's a waste of time and just wants you to renew it. From your assessment, the therapy continues to be appropriate. How should a pharmacist respond? (feel free to elaborate in the comments)
